<u>PARKING:</u> Please use only the designated parking area for your unit. **Only one car is permitted per unit.** Guest parking is restricted to maximum of three days without written approval of the board. Guest parking is for visitors only. **UNAUTHORIZED CARS WILL BE TOWED!**

SMOKING: SMOKING IS NOT PERMITTED ANYWHERE ON THE PROPERTY INCLUDING THE UNIT, THE LANAIS, AND ALL COMMON AREAS INCLUDING THE PICNIC AREA. GOOD HEALTH IS A COMMON GOAL

PETS: NO PETS ALLOWED, EVEN VISITING!

NOISE: Please keep radio, TV, etc. volume at a minimum as a courtesy to the other guests. **Do not slam doors when closing.**

<u>TRASH:</u> The trash and recycling units are located on the North-West side of the building. Each **trash container** is shared by two units and **numbered**. All trash must be in **SEALED PLASTIC BAGS** to avoid pests and rodents. EACH UNIT IS RESPONSIBLE FOR TAKING THE TRASH TO THE BINS. TRASH IS PICKED UP ON WEDNESDAY.

<u>RECYCLING:</u> Recycling is the responsibility of individual owner or guest. DO NOT THROW TRASH, PIZZA BOXES AND PLACTIC BAGS IN THE RECYCLE BINS. RECYCLE BINS ARE PICKED UIP ON TUESDAY.

<u>LAUNDRY ROOM:</u> Clothes lines are available in and outside of the laundry room. HANGING WET ITEMS OVER THE RAILING IS PROHIBITED. PLEASE KEEP THE LAUNDRY ROOM DOOR CLOSED TO KEEP THE BUGS OUT AND THE NOISE IN. PLEASE CLEAN THE LINT SCREEN AFTER EACH USE AND DISPOSE OF LAUNDRY BOXES AND SHEETS IN THE TRASH RECEPTACLE.

<u>WET TOWELS:</u> A clothesline is provided for wet beach towels behind the laundry room. Please do not hang items on the stairwell banisters.

<u>BEACH CHAIRS</u>: A temporary storage area for beach chairs, coolers and bikes is located under the stairwell near the picnic area. PLEASE DO NOT LEAVE BEACH CHAIRS OR OTHER ITEMS IN FRONT OF YOUR UNIT.

BARBECUE / COOKOUTS: ARE ONLY PERMITTED BEHIND THE LAUNDRY ROOM. Please place your grill at least ten feet away from the building. COOKOUTS ARE NOT PERMITTED ON THE LANAIS OR STAIRWAY LANDINGS. NO FOODSTUFF, PAPER PLATES, PACKAGES, ETC. IN THE LAUNDRY ROOM WASTE BIN PLEASE.
